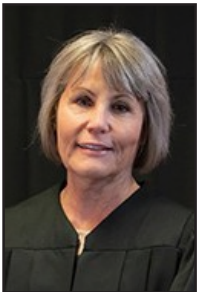

### Pandemic Preparedness and the Courts

Leigh Ann Retelsdorf is currently a judge of Nebraska's Fourth Judicial District Court, Douglas County. The Nebraska Judicial Branch has worked on preparedness in the event of a pandemic, hosting the National State Court Summit on Pandemic Preparedness at the University of Nebraska Medical Center last May.

"According to national experts, a pandemic is not just possible – it is highly probable," Chief Justice Heavican said. "Nebraska judges are now better prepared for the need to respond quickly and efficiently to pandemic quarantines and related legal issues."

The Nebraska Judicial Branch recently completed a bench book for judges and courts when facing the challenges of a pandemic outbreak. The writing of the bench book led to a partnership between Nebraska judges and administrators of UNMC's National Center for Health Security and Biopreparedness.

Along with Dr. Jeffrey Gold, UNMC Chancellor, and Carole McMahon-Boies, Administrator for Attorney Services, Judge Retelsdorf has been cited for her tireless work on this project.
